CHILD CARE AND PRESCHOOL

The JRC Learning Center is an early education center where primarily low to middle income children from age 6 weeks to 13 years old are intellectually, physically, emotionally, socially and cognitively prepared to succeed in life. In FY2017, 312 children were taught in a modern, kid-friendly and family oriented facility viewed as a safe haven by our parents and our community neighbors.

JRC Learning Center has provided quality early education and care since 1980. The Center is located at 2213 14th Street NE in the heart of northeast Canton, Ohio. Demographically, the Center provides services for low to moderate income families where parents and caretakers are either

SCHOOL - FREE AND REDUCED MEAL PROGRAM

In FY2017, the JRC Learning Center served 65,314 nutritious meals to children from 6 weeks to 13 years old. This represents meals served on average to 120 children per day. Some children stayed at the Center long enough to receive breakfast, lunch, and snacks. Children in low income families qualify for free meals provided in part by the Ohio Department of Education's Child and Adult Food Program.

The JRC Learning Center is an Early Head Start provider providing early education and wrap around services for 32 children (birth -- three years old) and families. Also, 30 preschool openings were provided to JRC, funded by the Ohio Department of Education, to teach 3 and 4 year olds in a

JRC teachers employ curriculum that aligns with Ohio Department of Education Early Learning Content Standards. Our initial outcome is that children will engage in developmentally appropriate activities that reflect best practices in early education and care in a high quality environment. Our primary long-term outcome is that children who consistently receive high quality education and care will increasingly display high levels of school readiness. In FY2017, 187 infants, toddlers and preschoolers participated in these early educational activities.
